I am to furnish herewith the sub-allocation of rice under 100 % Centrally Sponsored Scheme "ANNAPURNA" for distribution of 10 kgs. Rice free of cost to the indigent and destitute citizens of 65 years of age and above, who are not covered under National Old Age Pension Scheme (NOAPS) for the month of October/2009 to March/2010. The validity period for deposit of cost for Oct, 2009 will be 60 days from the date of GOI's Order and for remaining months, the validity period of deposit of cost and lifting of foodgrains will be as per extant guidelines dated 18/7/2008.


