Sub : - Sub-allocation of rice for the beneficiaries under 100% Centrally Sponsored Scheme "Annapurna".

Sir,

The Govt. of India vide letter No. 4-5/2012-BP-II dated 11/06/2012 has allotted Rice @ 476.1 qtls. per month under Annapurna Scheme at BPL prices for the year 2012-13. Accordingly, I am to furnish the monthly sub-allocation of rice under 100% Centrally Sponsored Scheme "Annapurna" for distribution of 10 kg rice per month free of cost to the indigent and destitute citizen of 65 years of age and above, who are not covered under National Old Age Pension Scheme (NOAPS) for the period from November, 2012 to March 2013. The validity period for deposit of cost and lifting of food grains will be 15th and 20th of each allocation month respectively.
