Sub :- Sub-allocation of rice for the beneficiaries under 100% centrally sponsored scheme "Annapurna".

Sir,

I am to furnish herewith the sub-allocation of rice under 100 % Centrally Sponsored Scheme "ANNAPURNA" for distribution of 10 kgs. Rice free of cost to the indigent and destitute citizen of 65 years of age and above, who are not covered under National Old Age Pension Scheme (NOAPS) for the month of Oct,2008 to March,2009. The validity for lifting of food grains will be 60 (sixty) days for each allocation month separately from the first day of the previous month of the allocation month and ending on the last of the allocation month. Payment of the cost of food grains allocated is required to be made latest by the 25th of each allocation month.
